



Calvert Soccer Association 2020 Raffle Rules and Regulations

Calvert Soccer Association a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting The Annual Facility Fund Raffle, to raise funds to support our facilities. The Rules and Regulations of the Raffle are set forth below. By purchasing or receiving a Raffle ticket the purchaser agrees to be bound by these rules and regulations. Calvert Soccer Association's interpretation and application of these rules and regulations shall be final.

The Grand Prize Drawing for the Raffle will be held on June 10th, 2020. Tickets will not be sold online after June 3rd, 2020. Tickets may sell out before that time. The drawing may be open to the public, but the winner does not need to be present to win.

Only 3,000 tickets will be sold. The chances of winning are based on that number. If fewer tickets are sold, your chances of winning the Grand Prize improves. The Internal Revenue Service (IRS) has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions. Raffle Tickets are not tax deductible.

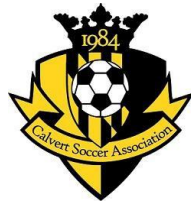

Tickets:

Tickets are \$20.00 each. One name, phone number, and one mailing address or email address are permitted per ticket. Only one eligible person may be entered in the raffle per ticket sold. If the name of more than one person is submitted with a ticket purchase, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of prize by a



group purchasing a ticket in common shall be to the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as a winner.

All raffle tickets must be received and/or purchased by the indicated deadline. Calvert Soccer Association assumes no responsibility for lost, late, misdirected or non-delivered mail or fax messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

A raffle participant's sole and exclusive remedy for Calvert Soccer Associations breach shall be limited to the return of the purchase price paid for his or her raffle ticket(s). In no event shall Calvert Soccer Association, its directors, officers, employees, agents or representatives be liable to any party for any loss or injuries to earnings, profits or goodwill, or for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages.

Selection of Winners:

The Calvert Soccer Association Annual Facility Fund Raffle drawing will be held on June 10th, 2020. Winners need not be present to win. Winner(s) will be notified according to the contact information provided to Calvert Soccer Association at the time of ticket purchase. If Prize winner(s) cannot be located and/or do not contact our main phone number by 5:00 p.m., on June 19th, 2020, after making a reasonable attempt to make contact through the information provided at the time of purchasing the Raffle ticket, such winner will be deemed to have elected to donate winnings back to Calvert Soccer Association. Another winner(s) will not be selected for such prize(s). The list of winners will be posted on Calvert Soccer Association's website and social media sites.

In order to collect his or her prize, a Raffle ticket winner will be required to sign and deliver to Calvert Soccer Association: (a) a sworn affidavit of eligibility in accordance with these Rules and applicable law, including without limitation that he or she is at least 18 years old (if applicable) at the time he or she purchased the winning Raffle ticket; (b) proof of identity in forms satisfactory to Calvert Soccer Association showing that the person claiming the prize is the same person who is named on the winning Raffle ticket. The Grand Prize winner may be required to submit a W-2G, Form 5754 or similar tax form (provided by Calvert Soccer Association) for tax withholding purposes. Prizes not claimed and/or collected by 5:00 p.m., on June 19th, 2020, will be forfeited and another prize winner will not be selected.
